The following sales contract is made for the mutual benefit and protection of both the Buyer and Seller. The parties involved in this transaction, Buyer and Seller, agree to the following terms and conditions:

- (1) Valhalla Mountain Kennels (Seller) is selling this puppy healthy and free of disease and has been vaccinated as appropriate for his/her age. Buyer agrees to keep all vaccinations up to date. All steps possible have been taken to insure that this dog is structurally, physically and psychologically sound.
- (2) Buyer must feed appropriate dog food, keep weight in check, and limit exercise in this young puppy. No jumping up or down from beds or couches, no excessive use of stairs, and no forced exercise until the puppy has matured to 12 months of age. Buyer is encouraged to give as much free exercise outdoors as possible.
- (3) Seller represents that to the best of their knowledge; the puppy you have purchased is in good health and is mentally alert. He/She will be examined by a veterinarian prior to its release from Valhalla Mountain Kennels. For the Buyer's protection, the Seller recommends that you have your own veterinarian examine the puppy within 5 days of purchase. Any dog found not to be in good health at that time may be returned for a full refund or other arrangements may be made as agreed to by the Buyer and Seller. If the puppy is to be returned it must be within 7 days of the exam and be accompanied by the attending veterinarians report. The exam costs are the responsibility of the Buyer.

(4) Spaying/Neutering is a must for your non-breeding dog. To reduce the risks of physiological unsoundness, veterinarians are recommending that this **not** be done before 12 months of age. The Seller does not guarantee against cryptorchidism unless full breeding rights are purchased (separate contract)

(5) WARRANTY: Valhalla Mountain Kennels always uses proven and sound breeding stock. All precautions have been taken for your puppy to grow up to be a sound and healthy adult. We do not “warranty” that your dog will be free of disorders that pertain to **all** large breed dogs due to their size (such as OCD). We do not warranty that your dog will be free of allergies to food or other environmental factors resulting in possible skin conditions or special dietary restrictions. We do not warranty against improper bite/ectopically erupting teeth which can be easily corrected with an extraction. Environmental factors play a large role in the health and development of your dog. It is the Buyer’s responsibility to provide a puppy food that is formulated for large breed dogs and to be cautious of over-exercise. If, within the first year of life, the puppy has a condition arising from a genetic disorder (such as - but not limited to - hip dysplasia, eye or elbow disorders) that is a screenable disorder then the Seller will offer a refund of 1/2 the purchase price towards the cost of veterinary care or surgeries **or** the Buyer may choose a replacement puppy from a subsequent litter (the original dog must be returned to the Seller). Valhalla Mountain Kennels will require a veterinary report prior to refunding any money or providing a replacement puppy.

Buyer and Seller agree to the above terms and that these two pages constitute the full contract.
